



**CALL FOR NOMINATIONS TO SERVE AS MEMBERS OF THE
AGRISETA ACCOUNTING AUTHORITY FOR THE TERM
01 APRIL 2025 TO 31 MARCH 2030**

The Agriculture Sector Education and Training Authority (AgriSETA), on behalf of the Minister of Higher Education and Training, Dr NP Nkabane, MP calls for the nominations of Accounting Authority. **Organized Labour, Organized Employers, Community Organization, Professional Bodies, Bargaining Councils and Government Departments**, within the Agricultural sector, are invited to submit nominations of suitably qualified candidates in possession of NQF Level 7 qualifications coupled with, amongst others, a blend of knowledge, skills, and experience required for the effective functioning of AgriSETA and the skills development system (preferably competent candidates with intensive expertise in the Agriculture sector, which includes technical experience and leadership capability). Preference will be given to female candidates, people with disabilities, youth, and women within the policy and legislative context to serve as member(s) of the AgriSETA Accounting Authority (AA and/or Board) effective from 01 April 2025 until 31 March 2030.

The following compulsory documents must accompany the completed Nomination Form and Acceptance of nomination signed where applicable by the candidate / nominees from Organized Employer, Organized Labour, Community Organization, Professional body indicating the availability of the nominee to serve on the Board, if appointed.

Brief and up to date Curriculum Vitae (CV) of the Nominee, with contactable references, Certified Copies of the Nominee's Qualifications (suitably qualified candidates in possession of NQF level 7 qualification).

In addition to the following mandatory background checks and verifications **MUST** be undertaken by the candidate, and for which documentary proof must be attached with the nomination:
